The petition of Barnett Shiloff respectfully shows

First. My full name is Barnett Shiloff

Second. My place of residence is number 133 Walnut street, city of Chelsea State of Massachusetts

Third. My occupation is manufacturer

Fourth. I was born on the 21st day of July, anno Domini 1877, at Kievka, Minsk, Russia

Fifth. I emigrated to the United States from Antwerp, Belgium, on or about the 6th day of August, anno Domini 1902, and arrived at the port of New York, in the United States, on the vessel Norman

Sixth. I declared my intention to become a citizen of the United States on the 2nd day of September, anno Domini 1903, at Boston, in the 11th Circuit Court of Dist. of Mass.

Seventh. I am married. My wife's name is Mary, and now resides at Chelsea. She was born in Chereva, and has three children.

and the name, date and place of birth, and place of residence of each of said children is as follows:
Hyman born March 15th 1901 at - Kievka
Anna " July 22nd 1905 at - Boston
Isidor " July 16th 1906 " - Boston
All now reside in Chelsea

Eighth. I am not a disbeliever in or opposed to organized government or a member of or affiliated with any organization or body of persons teaching disbelief in organized government. I am not a polygamist nor a believer in the practice of polygamy. I am attached to the principles of the Constitution of the United States, and it is my intention to become a citizen of the United States and to renounce absolutely and forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas II Emperor of Russia of which at this time I am a subject, and it is my intention to reside permanently in the United States.

Ninth. I am able to speak the English language.

Tenth. I have resided continuously in the United States of America for a term of five years at Chelsea immediately preceding the date of this petition, to wit, since the 15th day of November, anno Domini 1902, and in the State of Massachusetts for one year at least next preceding the date of this petition, to wit, since the 15th day of November, anno Domini 1902.

Eleventh. I have not heretofore made petition for citizenship to any court. (I made petition for citizenship to the COURT OF at Chelsea, on the 15th day of November, anno Domini 1902, and the said petition was denied by the said Court for the following reasons and causes, to wit, is, and the cause of such denial has since been cured or removed.)

Attached hereto and made a part of this petition are my declaration of intention to become a citizen of the United States and the certificate from the Department of Commerce and Labor required by law. Wherefore your petitioner prays that he may be admitted a citizen of the United States of America.
